Idol, antiques stolen from Jain temple

Bhopal: An idol of Mahavira and other antiques were stolen from a Jain temple in MP's Mandla district. The theft on Saturday triggered resentment among Jain community who held a protest alleging Jain temples were being specifically targeted. Police have failed to take action against the culprits, they said.

This is the second theft from Jain tem-

ples in the area within a week.

The theft took place at the Digambar Jain temple at Padav in Mandla. Police said the thieves collected eight idols, but left seven of them as they were of brass. They took the ashtadhatu idol (a combination of eight metals including gold, silver, copper, zinc, lead, tin, iron and mercury), along with several silver items and seven chhatris.

Last week, several silver items including a silver throne of Mahavira was stolen

from another temple.

Superintendent of police Gaurav Rajput said, "We are investigating both thefts. In this case, locks of the temple were not broken. It was opened and the idol and articles were stolen.

Members of the Jain community blocked traffic in front of the temple in Paday area protesting police inaction and demanding arrest of the accused. They later submitted a memorandum to the SP.

Gurdwara granthi burnt alive in Punjab

Amritsar: A Nihang Sikh (a sect of Sikhism) allegedly burnt alive a 'granthi' of a gurdwara after assaulting him in Punjab's Amritsar district. Nihang Shamsher Singh Shera committed the act on Friday. Police have registered a case against him and his family who are missing. Shera had terror links and was a drug addict, said

police. TNN

Man tosses wife, daughter into river in MP **Bhopal:** A man threw his wife and four-month-

old daughter into the Sindh River off a bridge in Bhind district. The woman miraculously survived the 200-feet fall. But, the infant has not been traced yet. The man committed the crime in a drunken state after a quarrel with his wife. The woman had been ostracised by her family and inlaws on suspicion of infidelity.

The woman's husband works in a private company in Delhi. Earlier, she had gone to the city, but was unable to locate her husband's house and wandered around in the capital for four days. This

jeev Jha, 27, tried to murder her wife and baby on the instigation of his parents and in-laws. They were married for seven years.

The incident took place near Medha villager under Ron police station, around 25 km from the district headquarters. Jha, a resident of Bhind's Lapwaha village under Lahar police station, was arrested from his home early on Sunday. He has been charged with attempt to murder.
